# Item 21.22.1: Previous Board of Governance Meeting Minutes - Action Taken and Institutional Report

Dr. V. Velmurugan, Principal, FXEC, presented the 21st Board of Governance Minutes and the action taken.

- (i) **Starting of Two New UG Programmes**: (i) Artificial Intelligence and Data Science & (ii) Computer Science and Business Systems are started from 2021-2022 onwards.
- (ii) **Starting of Two New PG Programmes:** With regard to the starting of PG Programmes, as only TWO NEW programmes are allowed to be started in an academic year, application for (i) M.E Structural Engineering (ii)) M.E Construction Engineering will be processed in 2021-2022 so as to begin the programmes in 2022-2023.
- (iii) Research Center for Mechanical Engineering: As per the norms the standing experience of PG should be 5 years. The application will be processed when the criteria is met.
- (iv) **Submission of SSR to NAAC:** The preparation of SSR is in Process and it will be submitted in the month of June 2022.
- (v)Submission of SAR to NBA: The work is in process, it will be uploaded in the month of December 2021.
  - (vi) Addition TWO add-on courses: Add-on courses are added in the curriculum by every Department as Value added Courses.

#### Points of Discussion:

#### The following are the suggestions given by the Council

- 1) SSR for NAAC shall be submitted in July 2020 with the 2021-2022 Updated Documents.
- 2) Results should be passed within 15 days from the completion of Examinations.
- 3) More importance should be given to add more practical cum theory courses in order to help the students get practical exposure.
- 4) Mentoring should be done at a different level to help students get accustomed to the New Normal.
- 5) Academic & Administrative Audit should be done by a 3 member committee once in every year.
  - a) AAA includes Verification as well as given input in form of suggestions at the end of the Audit'
  - b) The following 10 items need to be included in the Audit.
    - i) Is Curriculum under Autonomy meets Global Competence and Skill?
